Due to some family reasons, he is unable to continue at IIT, ISM Dhanbad. He has been given NOC by IIT, ISM Dhanbad, on the basis of which the scholar wants to take admission in our university.

It is worth mentioning that our university has not framed any rules for admission of Ph.D. scholars in such special cases as discussed above.

Since our university do not have rules governing admission of Ph.D. scholar in such cases, it is proposed that a committee may be formed to frame rules.
