Counseling Schedule, Instructions & Vacant Seat Position will be displayed/notified separately on the University Website. Accordingly, the University invites the 'FRESH APPLICATIONS' to fill up the vacant / left over seats of B.Tech Programs as per the following schedule:

- It is further informed that the candidates are required to **apply physically** and separately in each category **(AIC/TFW/EWS/KM)**. The Open Counseling shall be conducted only on the basis of merit of JE-Mains (for B.Tech) against the available vacant seats.
- The candidates are advised to check the Vacancy Position carefully before applying /reporting in Open Counseling, which shall be displayed separately on the University Website.
- Applications must be submitted as per the format available therein within the schedule at the Academic Branch of the University in person, along with the applicable application fee (applicable as per below) :

- Candidates who have already applied for admission to the B.Tech program through the University's online portal for the session 2024-25 are also required to submit a fresh application if they wish to participate in this open counseling. Otherwise, they will not be permitted to attend the counseling.
- Applications will be accepted in physical mode only.
