

- IV. To conduct the raids in the hostels and other places in the University to check whether there is any kind of indiscipline among the students which may be covered under the definition of ragging.
- V. To suggest and arrange program to aware the students about the menace of ragging by using resources like various cultural clubs in the university and District administration.
