Prof. Atul Mishra, Dean and Chairman chaired the meeting. The meeting started with the welcome of all the members by the Chair.

The following agenda items were discussed in the meeting:

Item No.BOF/01/01 : **To consider and confirm the minutes of 4<sup>th</sup> BOS (PG & UG) of Liberal Arts and Media Studies meeting held on 10.8.2020.**

The Board noted and approved the minutes of 4<sup>th</sup>BOS (PG & UG) meeting held on 10.8.2020 through online mode. A copy of the Minutes is enclosed herewith as **Annexure- I** for ready reference.

It was suggested that syllabus of the VAC 01: Human Values and Professional Ethics should be restructured. Some more topics such as happiness factor should be included. Following suggestions received:

1. It is suggested that the first unit should include Perception of Self and its relation with outer world with reference to Indian Civilization rather than Philosophies.
2. After detailed discussion it was suggested that appreciation of diversity in the world in terms of culture, languages etc. should be included in the first unit to sensitize students regarding human values. It can be done through open electives or audit courses.
3. It was emphasized the syllabus should have a practical approach and for that purpose case studies from real life should be included. Every student must do case studies and discuss in the class room.
4. It was suggested that industry people should be invited for MAJMC and M.A. English students for conducting workshops.

Item No.BOF/01/02 : **To consider and approve start of M.A. in Yoga and Naturopathy (2 years) and its scheme for the academic session 2020-22.**


The house was appraised about the start of MA in Yoga and Naturopathy (2 years) and its scheme for the academic session 2020-22. The chairman invited the suggestions on the syllabus. It was emphasized that there is a need to review the syllabus and Eligibility Criteria also. Copy enclosed as **Annexure- II** for ready reference.

Following points were emphasized:

1. M.A. in Yoga and Naturopathy must be affiliated with a professional body to run the course successfully.
2. Minor research project must be included in the Final Year.
3. Three months internship Programme from a recognized hospital must be introduced in M.A. in Yoga and Naturopathy.
4. Topics pertaining to Naturopathy should be more in the syllabus.

5. Practical aspects should be more so that students can practice Naturopathy
6. Specialization should be introduced either in Yoga or Naturopathy
7. In Eligibility Criteria Graduation in any discipline rather than B.A. in any discipline + one year diploma in Yoga (from recognized board/University) should be there.
