### > GENERAL INSTRUCTIONS:

All the candidates are advised to read and follow the instructions before reporting in the counseling:

- 1. The candidates must fulfill the eligibility criteria of the course:
  - Eligibility Criteria: Bachelor's degree (B.Sc. or B.Tech. or equivalent) in any branch of Science / Engineering / Technology / Agriculture with 50% marks in aggregate (45% for SC/ST candidates of Haryana only) from a recognized University/Institute/College.
- 2. The candidates are required to keep their original certificates/documents/ testimonials with him/her at the time of Manual / Institute Level counseling for verification.
- 3. Candidate must have to attend the counseling physically and also to present themselves in person before the admission committee for the allotment of seat. Physical attendance of the candidate at the counseling is mandatory.
- 4. Eligibility of the candidate for the admission is subjected to verification and submission of required documents at the time of admission.
- 5. If a candidate reports late for the document verification during counseling, he/she will be eligible only for the available seats at his/her turn after verification of documents.
- 6. Admissions must be within the sanctioned intake of the respective program and in accordance with the State Government Reservation Policy. (Please refer University Information Brochure 2024-25 and seat matrix notified vide number Acad/2024/1166 dated 21.06.2024)
- 7. The caste/reservation/annual income/financial benefits given to the candidates shall be based on verified caste/income data fetched through PPP (Parivar Pehchaan Patra) as per the State Government. Any unverified PPP data of the candidate shall lead to their candidature being considered in the general category only. All candidates seeking admission should be advised to get updated and verified their PPP ID.
- 8. Candidates have to deposit the Admission Fee amount Rs 36292/-. It is mandatory for the candidate to pay the requisite fee at the time of admission; otherwise, their admission will not be confirmed.
- 9. Admission Fee can be deposited in the form of Demand Draft (drawn in favour of "Registrar J.C. Bose UST, YMCA Faridabad") on the spot on offering the seat for admission. Payment can also be made by Debit/Credit card with applicable charges. Cash will not be accepted in any case.
