1.1 To confirm the minutes of Faculty of Engg. & Tech meeting held on 06-05-2014.

1.2 To report the action taken on various decisions of Faculty of Engg. & Tech meeting held on 06-05-2014.

Members noted the action taken report for the various decisions taken in the meeting held on 06-05-2014 and following deliberations were made:

a) Regarding conduct of workshop classes in Computer Engineering Department: The members noted the report of Chairman (CE) on the above issue and subsequent comments of Chairman (El) and Chairman (Electronics) as circulated. The importance of imparting workshop/ hardware knowledge was discussed at length in line with the availability of workshop staff in the department. Further, the members stressed the homogeneity with regard to the all other Engineering departments that are imparting workshop knowledge to the students.

It was resolved that Computer Workshop classes would be included in the curriculum and conducted in line with such inclusion in the other Engineering Department with effect from ensuing session 2015-16. Chairman (CE) would do the needful in this regard.

b) Regarding comparison of credits for different UG & PG programmes: The members noted the report on the subject of team under Chairmanship of Dr Rajesh Ahuja and resolved the following for all UG Engineering Courses:

Credits for Project Work: 4

Credits for Training: 12
