10. **Force Majeure:** The parties shall not be liable for any failure or delay in its performance under this agreement due to acts of god, civil or military authority, fires, epidemics, floods, earthquakes, riots, sabotage or disruptions of production facilitates, system failure technical mishaps, hacking, internet disruptions, loss of data, communications failure, strikes, work stoppages or other industrial disputes.

12. Intellectual Property Rights





