3. Notices

All notices, approval, instructions, demand and other communications given or made under this agreement shall be made in writing on the registered address given in the preamble/in first para.

4. **Severability**

5. Force Majeure

The parties shall not be liable for any failure or delay in its performance under this Agreement due to acts of God, acts of civil or military authority, fires, epidemics, floods, earthquakes, riots, sabotage or disruptions, of production facilitates, system failure technical mishaps, hacking, internet disruptions, loss of data, communications failure, strikes, work stoppages, or other industrial disputes.

6. Implementation of the Agreement

Specific details on the implementation of each area of collaboration shall be detailed in an "Agreement" done in writing. Such *Addenda* will include the specific activities to be conducted; responsibilities of each Party; participation, time and resources required; implementation procedures; and other details as necessary. 7. Intellectual Property Rights

Second Party will collect student data/information for functioning of their system including but not limited to their contact details, devices they have, and usage of applications/products assigned as project work. Second party and/or their customer will own this data within legal limits for required functioning of their business.

During interaction with students, all artifacts of training and project work, produced and/or referred will be intellectual property of Second Party and First Party will have no right on any of that. Artifacts agreed upon IP right of second Party includes but not limited to training and project work whether or not Student work product, in written, graphic, oral or other tangible or intangible forms, including, but not limited to: strategic plans; unannounced product information, specifications or designs; computer programs; documents, drawings, diagrams, models; studies, analyses, reports and processes.

Second Party charges their customers for the work done by enrolled users of their portal including Students. First Party will have no right and/or share on the earnings and/or business value created by Second Party.

8. Governing law and Jurisdiction

This Agreement shall be governed and construed in accordance with the laws of India. The Courts of Faridabad shall have exclusive jurisdiction in respect of any dispute between the Parties under this Agreement, which cannot be settled amicably.

9. Term and Termination
