#### **Existing Clause 1.17 (VI)**

The faculty members on extraordinary leaves may continue to guide the candidates registered for Ph.D programme under his/ her supervision in the University. However, no fresh registration of Ph.D scholars will be allowed by DRC for faculty members who proceeded extraordinary leaves. If the Supervisor(s) of a candidate leave(s) the University before the completion of the research work or is/ are otherwise unable to see the work through, due to some valid reasons, the Vice-Chancellor may allow a change of the Supervisor, as chosen by the candidate, on the recommendation of the

#### Proposed Clause 1.17 (VI)

#### **Change in Supervisor**

On the receipt of the request of the candidate through the Chairperson, a change in supervisor may be allowed by the DRC in the following circumstances:

- 1. The Supervisor superannuates and is no more the employee of the University.
- The Supervisor goes on extraordinary leave for extended period beyond one year
- 3. On the untimely demise of the supervisor
- 4. If the supervisor resigns

5. In exceptional circumstances by the order of the competent Authority.

#### **Allotment of Administrative Supervisor**

If the supervisor resigns and the work of the scholar is already complete i.e. the presubmission of the thesis is already done, an administrative supervisor may be allotted to the candidate by the DRC to look into the administrative work for thesis submission.

The allotment of the new supervisor should be approved by the PGBOS and Vice Chancellor.

As per directions of the Vice Chancellor, the proposed revision in the said clause is placed before the Council for discussion.
