At the outset, Dr. Arvind Kumar, Chairman welcomed all the members. Thereafter, the agenda item was taken up and after detailed discussion, the following decisions were taken:

Application for the extension of PhD registration of Mr. Parveen (11 YMCA U-640), for period of Six months for PhD thesis submission has been received and was presented before DRC committee.

As informed by supervisors, Mr. Praveen, research scholar, has completed his research work on the title 'Investigating the Properties of 3D Printed Thermosetting Reinforced Thermoplastic Composite'. However, the eligibility to submit Ph.D. requires at least two research publications in journals and two paper presentations in conferences. While five papers have been presented in the conferences, publication of the research papers in journals took some time, thereby delaying the submission of Ph.D. work.

As of now, three research papers have been published in Scopus-indexed journals, and four additional papers are currently under review. This satisfies and further enhances the publication requirement for the Ph.D. degree. The six-year period of Ph.D. thesis submission of Mr. Praveen is coming to an end on 22.01.2026.

In view of the above, as a special case, the committee considered and recommends the case for approval through the Competent Authority for six-month extension of his Ph.D. tenure
