- (ii) The members of the Executive Committee shall draw TA/DA from their respective Departments / Organizations. The members at Sr. No. 9 to 15 may claim TA/DA from HSCSIT for attending meetings of Executive Committee and/or for any other official work of HSCSIT.
- (iii) The Executive Committee should meet at least once in a year.
- (iv) The quorum of the meeting is fixed at one-third of the total membership of Executive Committee.
- (v) The headquarters of the Committee shall be at Panchkula.
