➤ **GENERAL INSTRUCTIONS:**

All the candidates are advised to read and follow the instructions before reporting in the counseling:

1. The candidates must fulfill the eligibility criteria of the course:

Eligibility Criteria:

Passed 10+2 examination or pass in diploma in Commercial Practice or equivalent from any recognized Board/ University with 50% marks in aggregate (45% in case of candidate belonging to SC/ST category of Haryana).

Admission shall be made on the basis of merit of the qualifying examination, wherein the percentage shall be calculated on the basis of the consolidated marks of the best five subjects listed in the DMC, with at least one of the five subjects being a language

2. The candidates are required to keep their original certificates/documents/ testimonials with him/her at the time of Manual / Institute Level counseling for verification.
3. Candidate must have to attend the counseling physically and also to present themselves in person before the admission committee for the allotment of seat. **Physical attendance of the**

candidate at the counseling is mandatory.

4. Eligibility of the candidate for the admission is subjected to verification and submission of required documents at the time of admission.
5. If a candidate reports late for the document verification during counseling, he/she will be eligible only for the available seats at his/her turn after verification of documents.
6. Admissions must be within the sanctioned intake of the respective program and in accordance with the State Government Reservation Policy.
7. The caste/reservation/annual income/financial benefits given to the candidates shall be based on verified caste/income data fetched through **PPP (Parivar Pehchaan Patra)** as per the State Government. Any unverified PPP data of the candidate shall lead to their candidature being considered in the general category only. **All candidates seeking admission should be advised to get updated and verified their PPP ID.**
8. Candidates have to deposit the Admission Fee amount **Rs 60929/-**. It is mandatory for the candidate to pay the requisite fee at the time of admission; otherwise, their admission will not be confirmed. Admission Fee can be deposited in the form of Demand Draft (drawn in favour of "Registrar, J.C. Bose UST, YMCA Faridabad") **on the spot** on offering the seat for admission. Payment can also be made by Debit/Credit card with applicable charges. **Cash will not be accepted in any case.**

The candidates must bring the following documents during reporting as per their Category: -

➤ **SC/SC(D)/BC Category Candidates:**

- Candidates belonging to SC, SC-D, BC-A, and BC-B categories must submit relevant category certificates issued by the competent authority. Parents of BC candidates (Block A & B) must submit an income certificate showing their gross annual income below Rs. 8 lakh and an affidavit regarding exclusion of Creamy Layer as per Annexure-VI of Information Brochure 2026-27 of the University. Annual family income should be verified from their PPP ID. For the criteria for exclusion of persons within the Backward Classes as Creamy Layer, please refer to Haryana Government Gazette No.107-2024/Ext. dated 16-Jul-2024.
- Domicile/Residence Certificate of Haryana State (if 10+2 is passed from outside Haryana State)

➤ **EWS (Economically Weaker Section) Category Candidates:**

- For admissions under the Economically Weaker Section (EWS) category, candidates must mandatorily provide the **EWS Income & Asset Certificate showing income below Rs.6 lakh**, issued by the Competent Authority of Haryana State only. A Resident/Domicile Certificate of Haryana is also mandatory to avail the benefits of the EWS category if the candidate qualified their last qualifying exam from another state. However, the family income of the candidate should be matched & verified from his/her PPP ID. In the event of non-availability of students in this category, the seat shall not be given to any other category of candidates.
- Domicile/Residence Certificate of Haryana State (if 10+2 is passed from outside Haryana State)

➤ **HOGC/ROHC Candidates:**

- Student claiming HOGC Category should be passed their 12th from the School situated in Haryana or they should possess the Domicile/Residence Certificate of Haryana State.
- Student claiming ROHC Category should be passed from the school situated Outside Haryana or they should possess the Domicile/Residence Certificate of State other than Haryana.

➤ **SGC (Single Girl Child) Candidates:**

- Student claiming SGC Category should be passed their 12th from the School situated in Haryana or they should possess the Domicile/Residence Certificate of Haryana State.
- The eligible Single Girl Child required to submit an affidavit on stamp paper worth Rs. 20/- duly attested by 1st Class Magistrate, to be obtained from the parents of the girl child declaring therein that the girl child is only a single child of their family not having any brother/sister.

➤ **Abandoned/Surrendered/Orphan children:**

- Domicile/Residence Certificate of Haryana State (if 10+2 is passed from outside Haryana State)
 - Certificate issued by the Competent Authority/ Body i.e. Concerned District Programme Officer
- Criteria for admission under this policy:-***

- a) Abandoned and Surrendered Children upto the age of 25 years who were admitted to the Child Care Institutions before the age of 05 year (as Abandoned) and before the age of 01 year (as Surrendered) and have completed the age of 18 years while living in Child Care Institution.
- b) Orphan Children, who have lost their parents (both father & mother) and is without biological or adoptive parents or legal guardian or whose legal guardian is not willing to take or capable of taking care of the child and having the family income (including guardian, if any) less than Rs. 2.00 Lakh per annum from all sources.
- Both (a) and (b) will be provided Free Higher Education including Technical Education alongwith hostel facilities in the University. However, minimum eligibility criteria of respective courses as per University Information Brochure notified time to time, must be fulfilled by the applicants

➤ **KM/TFW/PH/ESM/FF Candidates (if applicable)**

- For admissions under the **Tuition Fee Waiver (TFW) category**, the candidate must provide an Income certificate issued by the Competent Authority of Haryana State, stating an income of less than Rs.8 lakh from all sources and verified through their PPP ID. Additionally, a Resident/Domicile Certificate of Haryana is also mandatory to avail the benefits of the TFW category if the candidate qualified their last qualifying exam from another state. Candidates admitted in this category shall not be allowed to change the institution/program under any circumstances. In the event of non-availability of students in this category, the seat shall not be given to any other category of candidates.
- Kashmiri Migrant (KM) Certificate issued by the competent authority or Relief commissioner.
- PH certificate must be issued from Chief Medical Officer of the concerned District
- ESM certificate as per annexure-X (as applicable) of Information Brochure **2026-27**
- Freedom Fighter certificate as per Annexure-VIII of Information Brochure **2026-27**
