Dr. Rajeev Saha presented the case to the committee.

Ms. Chanchal Bhardwaj, Ph.D. scholar (Roll No. 20001912002) was admitted to Ph.D. (Interdisciplinary) in academic year 2020-21 with Dr. Rajeev Saha as supervisor and Prof. Amita Yadava (Retd. From Dept. of Psychology, MDU, Rohtak) as her research topic was a mix of manufacturing and psychology. However, Prof. Amita Yadava being a retired professor needed approval from Research Promotion Board (RPB) of the university to become co-supervisor. Subsequently, the RPB (now RAC) meeting was held on 15th March 2023 after a gap of almost two years. The RAC didn't approve of her, being a retired professor, for co-supervisor.
