

BOS/25/03	To apprise the members about implementation of 'Environmental Science' as a compulsory subject in all University undergraduate programs from the academic session 2025-26 as per 30th Academic Council meeting dated 25.11.2024 (Annexure C) For the implementation of 'Environmental Science' subject in all the UG programs of Mechanical department, a committee of following members was constituted. <ul style="list-style-type: none"> • Prof. Hariom (Chairperson) • Prof. Sandhya Dixit (Member) • Dr. Rajeev Saha (Member) • Dr. Rajesh Attri (Member) The committee found that department is already running three courses related to EVS in different semesters as detailed below: <ol style="list-style-type: none"> i. Environment and Ecology (MCEVS-01) – 2nd Semester ii. National Resources and Biodiversity Conservation (MCEVS-02) – 4th Semester iii. Environment Pollution, Waste Management and Sanitation (MCEVS-03) – 6th Semester After going through the syllabus of Environmental Science (approved in 30 th Academic council dated 25.11.2024), it was observed that the syllabus contents are almost covering the contents of the three courses MCEVS-01, MCEVS-02, MCEVS-03. Accordingly, it was proposed to introduce the course Environmental Science (ESU-203-V) in 4 th semester in lieu of the previous three courses mentioned above. This has also been discussed with and consented by Dr. Renuka (Chairperson, EVS). <p><i>The revised scheme of B.Tech (Mechanical Engineering, Robotics & Artificial Intelligence) and syllabi for Environmental Science, offered by the Department of Mechanical Engineering, was presented before the members of the Board. The Board of Studies approved the same.</i></p>
