> GENERAL INSTRUCTIONS:

All the candidates are advised to read and follow the instructions before reporting in the counseling:

1. The candidates must fulfill the eligibility criteria of the course:

Eligibility Criteria: Passed 10+2 examination or equivalent from any recognized Board/ University with 50% marks in aggregate (45% in case of candidate belonging to SC/ST category of Haryana).

Admission shall be made on the basis of merit of the qualifying examination, wherein the percentage shall be calculated on the basis of the consolidated marks of the best five subjects listed in the DMC, with at least one of the five subjects being a language.

In case two or more candidates have same percentage in qualifying exam, then the applicant senior in age (as per D.O.B) will have higher merit.

In case candidates have same percentage in qualifying exam and have same D.O.B., then the candidate having higher percentage in 10th will have higher merit.

2. The candidates are required to keep their original certificates/documents/ testimonials with

- him/her at the time of Manual / Institute Level counseling for verification.
3. Candidate must have to attend the counseling physically and also to present themselves in person before the admission committee for the allotment of seat. **Physical attendance of the candidate at the counseling is mandatory.**
 4. Eligibility of the candidate for the admission is subjected to verification and submission of required documents at the time of admission.
 5. If a candidate reports late for the document verification during counseling, he/she will be eligible only for the available seats at his/her turn after verification of documents.
 6. Admissions must be within the sanctioned intake of the respective program and in accordance with the State Government Reservation Policy. **(Please refer University Information Brochure 2026-27 and seat matrix, (already notified))**
 7. The caste/reservation/annual income/financial benefits given to the candidates shall be based on verified caste/income data fetched through **PPP (Parivar Pehchaan Patra)** as per the State Government. Any unverified PPP data of the candidate shall lead to their candidature being considered in the general category only. **All candidates seeking admission should be advised to get updated and verified their PPP ID.**
 8. Candidates have to deposit the Admission Fee amount **Rs. 51975 /-**. It is mandatory for the candidate to pay the requisite fee at the time of admission; otherwise, their admission will not be confirmed.
 9. Admission Fee can be deposited in the form of Demand Draft (drawn in favour of "Registrar J.C. Bose UST, YMCA Faridabad") **on the spot** on offering the seat for admission. Payment can also be made by Debit/Credit card with applicable charges. **Cash will not be accepted in any case. - The eligible Single Girl Child required to submit an affidavit on stamp paper worth Rs.20/- duly attested by 1st Class Magistrate, to be obtained from the parents of the girl child declaring therein that the girl child is only a single child of their family not having any brother/sister.

- Domicile/Residence Certificate of Haryana State (if 10+2 is passed from outside Haryana State)
