- Certificate of experience, if any, with clear mention of designation, time-period and pay level/band with grade pay which must be supported with Salary slip/ PF Statement/ Form-16, Bank Statement or any other valid proof of salary paid as claimed. Irrelevant (not as per requisite conditions) experience will not be considered.
- Any other documents as requisite for the eligibility for respective post.
