

Accordingly, all above short-listed applicants are hereby informed to report/ attend the **document verification process on November 17, 2023 at 09:00 AM onwards** in the Multimedia Centre (MMC) of the University, along with all original certificates in support of their eligibility, as per specified conditions at the time of document verification. All concerned are advised to bring the originals of following document along with 02 set of self-attested photocopies:
 - a) Aadhaar Card along with one other valid Identity & address proof and 02 passport size photographs.
 - b) Certificate for claiming benefits of reservation of SC & BC-A Category issued from the Competent Authority as specified by the State of Haryana on the prescribed format only, along with Domicile/ Haryana Resident certificate & latest Income Certificate (for BC-A).
 - c) 10th, 12th or equivalent, graduation and post graduation mark-sheets and certificates.
 - d) Certificate of experience, if any, with clear mention of designation, time-period and pay level/band with grade pay which must be supported with Salary slip/ PF Statement/ Form-16, Bank Statement or any other valid proof of salary paid as claimed. Irrelevant (not as per requisite conditions) experience will not be considered.
 - e) Any other documents as requisite for the eligibility for respective post.
- 3. Accordingly, it is cleared that if any of the above requisite documents is not produced at the time of document verification, the respective information/ data will not be considered which may lead to ineligibility. No time will be permissible to submit any document later. If an applicant does not report for document verification, he/she will not be considered for further process of selection.
