TENTATIVE COUNSELLING SCHEDULE & GENERAL INSTRUCTIONS B.Voc Automobiles Schedule for Reporting On 19.07.2023 (WEDNESDAY)

- The counselling will be conducted in "Offline" mode according to the enclosed counselling schedule for B.Voc and UG/PG Diploma Programs in the Community College of Skill Development (3rd Floor above Account Section).
- It is mandatory for all candidates to physically report to the University during the counselling at specified date and time.
- For eligibility criteria and fee structure, candidates should refer to the information Brochure 2023-24 for UG/PG programs of the University available at University website.
- The seats will be filled strictly based on the reservation policy notified by the State Government of Haryana.
- The merit list displayed on the University Website is tentative and subject to physical verification of the original documents at the time of counselling.
- Candidates are advised to regularly visit the University Website: http://jcboseust.ac.in/ for updates.
- The candidate can make the fee payment through UPI transfer or Cash.
- It is mandatory for the candidate to pay the first semester fee at the time of admission, otherwise, their admission will not be confirmed.
- Candidates must attend the counselling in person and be present before the admission committee for seat allotment. Physical attendance at the counselling is mandatory.
- The eligibility of the candidate for admission is subject to verification and submission of required documents at the time of admission.
- The caste/reservation/annual income/financial benefits given to the candidates shall be on the basis of verified caste/income fetched through PPP (Parivar Pechaan Patra) as per State Govt.
- Foe admissions under the Economically Weaker Section (EWS) category, candidates must mandatorily provide the EWS Income & Asset Certificate with an income below Rs.6 Lakh issued by the Competent Authority of Haryana State only. Resident/Domicile Certificate of Haryana is also mandatory to avail the benefits of the EWS category.
- For admissions under the Tuition Fee Waiver (TFW) category, the candidate must provide the Income certificate issued by the Competent Authority of Haryana State, stating an income of less than Rs.8 Lakh. Additionally, a Resident/Domicile Certificate of Haryana is also mandatory to avail the benefits of the TFW category.
- If a candidate has passed the 10+2 examination from Haryana state, the resident/domicile certificate is not mandatory for admissions under the HOGC category.
- If a candidate arrives late for document verification during counselling, they will only be eligible for the available seats at their turn after the verification of documents.

- The admission committee will verify the eligibility of the candidate based on all the original documents. Therefore, candidates are advised to bring the following documents (in original) along with two sets of self-attested photocopies during the counselling.
- If any board/University issues Migration Certificate only in an online mode, students who have passed out from such board / university must submit an affidavit along with the online-issued Migration Certificate.
