TERMS AND CONDITIONS FOR BENEFICIARIES – FINANCIAL ASSISTANCE PROGRAMME

1. The applicants are selected as a beneficiary under the FINANCIAL ASSISTANCE program of Vishwa Prakash Mission (VPM) based on their request, economic, social conditions and marks secured in school/college
2. This program will provide financial assistance for educational expenses mainly and other expenses may be borne by the Trust depending on merit of the case. Invariably assistance will be directly paid to the respective educational institutions.
3. VPM shall have the full right to change the quantum of assistance and can decline continuation of same. Decision of VPM shall be final and no claim shall be entertained in this regards from the student and/or parents.
4. If the selected beneficiary receives any form of financial assistance from the Govt/State or Central/Private institutions, the quantum of benefit may be totally discontinued.
5. The beneficiaries will have to provide self certified copies of receipt of fees, exam results periodically, failing which future requests will not be entertained by the mission.
6. The mission has full right to enquire about the conduct, academic performance of the beneficiaries from the educational institutions. The beneficiary or other persons connected with the beneficiary shall not have any right to interfere.
7. The beneficiaries and other connected persons of the beneficiaries should not in any way use the name of the mission for wrongful means, purpose and self promotion.
8. Beneficiaries during their period of studies should not indulge in unlawful activities, should not cause any harm/ damage to public properties, college, staff and students. Vishwa Prakash Mission can discontinue further financial assistance, if any such thing happens.
9. Beneficiaries should not marry during their study period. If it is known to the contrary they will be disqualified from the Scholarship Program immediately.
10. Beneficiaries should observe decency with other beneficiaries. They should not interfere with other's rights.

11. Parents/Guardians whenever if called by the Mission with regard to the complaints on their wards, they should personally attend to the same.
12. Beneficiaries should inform any changes in their address/contact numbers to VPM and should be in contact with VPM / its staff/ volunteers..They should attend the training session /seminar if any arranged by Vishwa Prakash Mission to improve their capabilities.
13. Beneficiaries have to inform their personal requests, grievances or complaints about staff of the mission to VPM only and they undertake not to raise the issue with any outsider/outside agency etc.
14. Beneficiary and his/her parents will have no objection in VPM publishing names, photos and result of the students assisted by the mission.
15. The Beneficiaries removed as per above procedure may be called to return concessions, financial assistance given to them by Vishwa Prakash Mission.
