A concise, up-to-date description of the background to provide the reader with enough context to understand the research being presented and its significance, as well as providing a clear statement of the research question and any hypotheses being explored.

Materials and Methods

Techniques, materials, and equipment are described in sufficient detail for another trained researcher to be able to reproduce the experimental work reported. Methods that are identical to published procedures should still be summarized in brief and include a citation to the original work.

Experimental setup

Use subsections to clearly indicate the experimental procedure or modeling. In submissions that have a significant theoretical or mathematical component, a description of the analytical procedures may be required.

References should follow the conclusions. The references should be listed in numerical order with the corresponding number cited inside the printed manuscript within square brackets at appropriate places [1], [2]. Please use IEEE reference style shown below.

Manuscript must be typed in English using Times New Roman font in MS Word. Kindly follow the instructions given below for all the pages.

Title : 16 point. Capital and Bold

Author's Name : 11 point Affiliations : 11 point

Headings : 14 point and Bold Subheadings : 13 point and Italic

Body Text Font : 12 point

Spacing : Single line spacing

Margins : Top 1"

Bottom 1" Left 1" Right 1"

Length of Paper

The length of manuscript should not exceed 15 pages, including, figures, tables and references.

Figures and Tables

All figures should be captioned and inserted in appropriate place of the paper. Caption for the figures should be printed below the figures and numbered consecutively throughout the text. Tables with title and content with 10-point font size should be placed closest to the text of its use and the title is to be written on its top.
