Sub: Affiliation status of Echelon Institute of Technology, Faridabad

Whereas, each of the affiliated Institution requires to abide by the conditions of affiliation laid down in the affiliation Ordinance of this University. As per Clause 9 (b) of the said Ordinance, continuation of provisional affiliation of academic programmes in any Institution is granted on year to year basis through inspection process prescribed in Clause 8 of this Ordinance.

2. Whereas, Echelon Institute of Technology (EIT), Faridabad had initially prohibited the University to conduct the inspection and further failed to facilitate the conduct of inspection by the University for continuation of its provisional affiliation for academic year 2019-20, despite various communications by the University including the Show-Cause Notice dated 24.05.2019 in this regard. Further, the reply to this Show-Cause Notice submitted by the EIT Faridabad dated 31.05.2019 was also found not satisfactory and EIT Faridabad failed to get the inspection done, which is mandatory for continuation of its provisional affiliation, even after withholding of registration of its students. EIT Faridabad had not even conveyed the continuation of already registered students in various academic programmes in academic session 2017-18 & 2018-19. Moreover, the EIT Faridabad did not avail the final opportunity of inspection visit by the University vide letter dated 05.08.2019 meaning thereby that the Institute is no longer willing to remain affiliated with this University.

3. In view of above, it became imperative to withdraw the privileges of affiliation to which EIT Faridabad was admitted in the Year 2017, as per Clause 13 (b) of the affiliation Ordinance and EIT, Faridabad was informed vide letter dated 30.09.2019 about initiation of process of withdrawal of its affiliation privileges.

4. In such unavoidable circumstances, the privileges of affiliation to which EIT Faridabad was admitted by this University are hereby withdrawn with immediate effect and thus, EIT Faridabad is not affiliated to this University w.e.f Academic Year 2019-20.
