Whereas, the incidence of corona virus is increasing in the district and it has been declared a pandemic under the Epidemic Disease Act, 1897

Whereas, it is of utmost important and in the public interest that additional facilities for use as COVID Care Centre in order to prevent the spread of infection and to facilitate the infected persons who cannot be home quarantined be developed

Therefore, I Garima Mittal, IAS, District Magistrate, Faridabad being the competent authority under the Haryana requisitioning and Acquisition of Immovable Property Act, 1973 and under "The Haryana Epidemic Disease, COVID-19 Regulation 2021" issued under "The Epidemic Disease Act, 1897" do hereby, temporarily requisition, with consent, the following more buildings also included to function as COVID Care Centres during the pandemic :-

1. Mother Tersi Hall, Kasturba, Sarojini, Kalpana, Girls Hostel J.C. Boss University, Faridabad.
