Only those students will be granted scholarship whose Saving Bank A/c. no. has been "Mapped with their Aadhar No. So, all SC/BC students are directed to mention only that Saving Bank Account No. in the application form that is mapped with their Aadhar Card & submit the copy of the same after getting the printout from the website, i.e. <a href="https://resident.uidai.gov.in/bank-mapper">https://resident.uidai.gov.in/bank-mapper</a> to Scholarship branch (DSW Office) along with application form.
